Guidelines for the Establishment of the "Certificate Program (Undergraduate) for English for Specific Purposes (ESP)"

- 第一條、 本要點依據「國立臺北大學學分學程設置辦法」第三條及「國立臺北大學學程修 讀辦法」規定訂定之。
- Article 1: These guidelines are established in accordance with Article 3 of the "Regulations on the Establishment of Credit Programs at National Taipei University" and the "Regulations on Studying Programs at National Taipei University."
- 第二條、 設立宗旨:為針對本校非應用外語系學生,提供跨領域之專業英語學習環境,藉 由全英語教學之專業主題課程,強化並提升學生專業英語素質,培育適應未來國 際化社會暨生涯發展之語言能力,特設置「ESP專業英文學士學分學程」。
- Article 2: Objective: To provide students who are not majoring in Foreign Languages and Applied Linguistics at the university with an interdisciplinary professional English learning environment, enhance and improve their professional English skills through all-English instruction in professional subject courses, and cultivate language abilities that meet the needs of an internationalized society and future career development. Therefore, the "ESP Professional English Bachelor Credit Program" is established.
- 第三條、 本學程置召集人一位,負責規劃本學程相關課程及執行推動本學程相關業務;召 集人由本中心主任兼任或由教務長推薦本校相關系所專任教師擔任之。
- Article 3: The program shall have one convener responsible for planning relevant courses and promoting the related affairs of this program. The convener shall be concurrently held by the Director of the Center or recommended by the Dean of Academic Affairs from among the full-time faculty of the relevant departments.
- 第四條、 本校大學部(含進修學士班)學生無需先行申請,皆可依個人興趣修讀本學程。
- Article 4: Undergraduate students (including those in the continuing education bachelor's program) may enroll in this program based on their interests without prior application.
- 第五條、 本學程課程規劃表另訂之。本學程分「專業英文」(ESP)課程及「跨領域之全英授課」(跨領域 EMI)課程。
- Article 5: The curriculum plan for this program shall be established separately. The program includes "Professional English" (ESP) courses and "Interdisciplinary EMI (English-Medium

Instruction)" courses.

- 第六條、 欲取得本「學分學程結業證明書」之學生,須修畢至少 16 學分,其中「跨領域之 全英授課」(跨領域 EMI)課程修習至多 2 門且不屬於其主系、雙主修學系及輔系 之必修科目。
- Article 6: To obtain the "Credit Program Certificate," students must complete at least 16 credits. Among these, up to 2 courses can be taken in "Interdisciplinary EMI (English-Medium Instruction)" and must not be mandatory subjects of the student's major, double major, or minor programs.
- 第七條、 欲取得本「微學程結業證明書」之學生,須修畢至少 8 學分,其中「跨領域之全 英授課」(跨領域 EMI)課程修習至多 1 門且不屬於其主系、雙主修學系及輔系之 必修科目。
- Article 7: To obtain the "Micro-Program Certificate," students must complete at least 8 credits. Among these, up to 1 course can be taken in "Interdisciplinary EMI (English-Medium Instruction)" and must not be mandatory subjects of the student's major, double major, or minor programs.
- 第八條、 修習本學程之學生每學期所修學分上、下限仍依本校學則相關規定辦理,其選課 受課程限修人數之規範。
- Article 8: The upper and lower limits of credits per semester for students enrolled in this program shall comply with the relevant regulations of the university. Course selection is subject to enrollment limits.
- 第九條、 修習本課程之科目成績,須併入學期修習總學分及學期成績計算。且不得以未修 滿學程學分申請延長修業年限。
- Article 9: Grades for subjects taken in this program shall be included in the total semester credits and GPA calculation. Failing to complete the required credits for the program may not be used as a reason for students to extend their study period.
- 第十條、本學程每學年之認證並無名額限制。選修生申請認證者,本學程每一科目成績須達 75分(含)以上,並檢具「歷年成績單」正本及「本學分學程申請書」,於畢業前向本中心提出認證申請。經本中心審核無誤並報請教務長或進修暨推廣部部主任同意後,由校級行政單位發給學分學程結業證明書。
- Article 10: There is no limit to the number of certifications issued each academic year. Students applying for certification must achieve a score of 75 or above in each subject and submit the official transcript and the "Credit Program Application Form" to the Center for certification before graduation. The university administrative unit will issue the credit program certificate after review and approval by the Center and the Dean of Academic Affairs or the Director of the Continuing Education and Extension Division.

- 第十一條、本要點如有未盡事宜,悉依本校及教育部相關法令規定辦理。
- Article 11: Any matters not covered in these guidelines shall be handled in accordance with the relevant regulations of the university and the Ministry of Education.
- 第十二條、本要點經中心會議通過後送校課程委員會審議通過後公告實施,修正時亦同。
- Article 12: These guidelines shall be implemented after being approved by the Center's meeting and the University Curriculum Committee, and the same procedure shall apply to any amendments.
